IT IS SEA TURTLE NESTING SEASON!

Nesting occurs from May to October every year. Please tell



all visitors and friends to be mindful of these protected areas. In 2022, St Johns County beaches had a record 1,235 nests! Please fill in holes and knock down sandcastles that may obstruct the sea turtles on their way to the ocean. If you are lucky enough to witness a sea turtle hatching, please watch from a distance, do no touch the animal and avoid the use of cell phone light or flashlights.

BOARDWALK UPDATE

In April, the Florida Department of Environmental Protection let the city know that the state laws regarding changing the existing boardwalk would require a replacement in kind. Rule 62D.5.059, section 3 states "the grantee shall replace the area, facilities, resource, or site <u>at its own expense</u> with project of comparable scope and quality". Moving the boardwalk from its current location to the FCT Parcel, which is the area north of the boardwalk currently under renovation, would not meet this requirement as this area has in part been purchased with state funds and would not meet the requirement of the City of St. Augustine beach moving the boardwalk at its own expense. The City would be required to build a comparable boardwalk on City-owned property.

Additionally, the City received a quote for Phase 3 projects in the Park which were significantly over budget so the City has informed the FCT to delete these projects and only complete work already started. We thank Jim LeClare for all his efforts and determination to advocate for our much-loved boardwalk and our community's ability to continue using it. Thank you, Jim!
